Conditions of Entry

All participants in the FDC Ride to Give 2024 event, are required to read and sign these conditions of entry. By signing this document you are stating you fully understanding and agree to these conditions of entry and individual responsibilities as set out herein and also given to you by FDC and all volunteers and employees of FDC.

- 1(a) I, the undersigned, in consideration of and as a condition of acceptance of my entry in the ride for myself, my heirs, executors and administrators hereby waive all and any claim, right or cause of action which I or they might otherwise have for or arising out of my loss of life, damage or loss of any description whatsoever which I may suffer or sustain in the course of or consequent upon my entry or participation in the said event AND I agree that I participate in the said event solely at my own risk.
- 1(b) I acknowledge that the ride will be held on public roads which are in use by the general public during the ride and I agree to abide by any law relating to the use of public roads. I acknowledge that riding on a public road is inherently dangerous and I am aware of the risks of collision with motor vehicles, bicycles or pedestrians and agree to exercise proper care and skill to avoid any collision. I am also aware of the risks of crashing due to uneven surfaces, potholes or gravel.
- 2. This waiver, release and discharge shall be and operate separately in favour of all persons, corporations and bodies involved or otherwise engaged in promoting or staging the event and the servants, agents, representatives and officers of them, any host, first aid, medical and paramedical personnel, police officers and shall operate whether or not the loss, injury or damage is attributable to the act or neglect of any one or more of them.
- 3. I hereby acknowledge that I have sole responsibility for my personal possessions and equipment during the ride.
- 4. I hereby attest and verify that I am physically fit and have sufficiently trained for this ride and can ride safely in a peloton at the agreed base level of fitness and rider experience for this event. If requested, I agree to provide a signed doctor's certificate attesting to my physical health and fitness to participate in this ride and if requested, attend a qualification training ride to qualify.
- 5. I hereby consent to receive medical treatment, which may be deemed necessary in the event due to injury, accident and/or illness during the ride.
- 6. If requested, I agree to present my bike before the ride at the times to be advised to allow it to be inspected and will abide the decision of the organizers as to ride-worthiness or suitability for the ride. Notwithstanding such an inspection, I acknowledge that I at all times remain responsible for ensuring that my bike is ride-worthy, has been properly maintained and serviced and is in a suitable condition to be able to undertake the ride safely.
- 7. I understand this ride has been sanctioned by Cycling Australia and it's mandatory that I have current ride membership with Cycling Australia to participate in this ride.
- 8. Under no circumstances whilst riding my bike will I listen to MP3 Players / music and or have ear buds of any kind reducing my ability to hear ride captains, other riders and or traffic around me and others.
- 9. I understand I need to ride safely in a peloton alongside other riders and I need a road / race bike in good working condition to participate in this ride and that no hybrids, mountain bikes, tri bars, tandems, recumbent bikes are allowed. I acknowledge any request by me to ride a bike that does not conform to a road / race bike specification, needs to be lodged by me to FDC & Entoure before the event to be properly assessed
- 9. I understand and accept that the event has a zero-alcohol policy whilst cycling and that under no circumstances will I consume alcohol during the ride.
- 10. I have read these Conditions of Entry and agree to abide by them.
- 11. "Ride" means the FDC Ride to Give 2024 charity bike ride.
